

## Subscription Terms

Please read carefully through these terms before subscribing.

### User agreement to EmergingTextiles.com ([www.emergingtextiles.com](http://www.emergingtextiles.com))

This agreement is made between you (as the user) and EmergingTextiles.com. When you subscribe, it constitutes agreement to the terms and conditions in respect of your access to and use of EmergingTextiles.com ("the Web Site"). You must agree to be bound by all these terms and conditions. If you do not agree, do not use this Web Site.

### All Subscriptions:

A subscription to EmergingTextiles.com provides full access to our content, including the web site's "price reports" and the "price database" without any restriction. Historical data are available for download through csv files. The subscription is for one year (12 months) duration.

This agreement will continue until either you or EmergingTextiles.com terminates it, or your subscription expires. Either party may terminate it at any time by sending notice of termination to the other party. On termination, you will cease to have the right of access to the Web Site. There will be no refund. There is no automatic renewal at the end of the subscription period. A few weeks before the end of the subscription period, you will be sent a renewal email message with the option to renew.

### Subscription Options

Access is granted only to collaborators with a professional email address under the same domain name. Collaborators of different entities or subsidiaries under the same group cannot benefit from the corporate subscription, if they do not have a professional email address with an identical domain name. The corporate subscription is for personal use only. Sharing access details or sending data to other

collaborators, except other subscribers, will immediately result in the end of the subscription and associated access rights, with immediate effect.

A **Global Subscription** provides access to the full content for 30 collaborators of the same group or organization. Access is only granted to collaborators with a professional email address and a unique domain name. Other entities or subsidiaries of the same group or organization operating under a different domain name must subscribe separately.

Data supplied by EmergingTextiles.com cannot be sent to anyone outside the group or entity including to other entities of the same group or organization with a different domain name. Any dissemination of our data will result in immediate termination of the subscription.

The global subscription offers the right to aggregate EmergingTextiles.com's data in a price database available to all collaborators of the same entity operating under an identical domain name.

A customized database page can be built upon request from the subscriber, offering access to a spreadsheet including a selection of products available on the web site.

A single and confidential web address (URL, or Unique Remote Location) is supplied by EmergingTextiles.com for accessing and downloading this customized spreadsheet. In any case can this URL be transmitted by the subscribers or by EmergingTextiles.com to any other entity.

The passwords must be retained confidential and may not be shared with someone else either transmitted to another person.
